The Connecticut Farm Energy Audit Program is providing discounted energy audits to help identify projects that reduce farm energy costs through energy efficiency. An energy audit can be used to apply for USDA grants and incentives through several programs including the Rural Energy for America Program (REAP). *Please note that you are required to pay for 25% of the cost of your energy audit.* The cost of your energy audit will depend on the size and complexity of your operation and will be determined once you have submitted this application. To be eligible, farms must be either be in eligible rural areas or confirm that at least 50% of the farm's gross income comes from agriculture operations. You may be required to provide additional data to determine eligibility.
